

CRITERIA

F. Lynn Mayer Memorial Scholarship

PURPOSE:

The F. Lynn Mayer Memorial Fund provides financial assistance to a student from Catonsville High School, Baltimore County, Maryland, to be determined based on the amount of money available in accordance with the terms of this agreement. In addition, if income in any given year is sufficient, grants for other charitable purposes may be made in Mr. Mayer's memory.

GENERAL CONDITIONS:

RESPONSIBILITIES OF MEMORIAL FUND

The Community Foundation will transmit checks made payable to the institution of higher learning to be attended on or about July 1st of each year. The transfer will be in accordance with applicable regulations and laws governing such trusts.

RESPONSIBILITIES OF BOARD

- A. The chosen recipient will be selected in accordance with the selection criteria identified in this document and the Memorial Fund Agreement.
- B. The Community Foundation of Carroll County shall administer the program in a prudent financial manner.
- C. The Community Foundation of Carroll County shall submit an annual financial report to the Donor and/or her designee.

SCHOLARSHIP SELECTION CRITERIA

- A. A scholarship will be awarded each year to a student who meets the following criteria:
 - Scholarship should be awarded based on financial need.
 - Academic Excellence; Student must excel in Humanities/Math or Science
 - Extra Curricular Participation; Student must participate in extra curricular activities: Athletics, Drama and Music
 - Exemplary Character; Student must demonstrate real concern for others as evidenced through service learning, contributions to school and/or the community-at-large. Must be respected by both peers and staff.
 - Future Goals; Intended major should be education, medicine, scientific research
- B. The administration of the scholarship shall be as follows:
 - The recipient shall be selected by the scholarship committee of Catonsville High School and approved by the Board of Directors of the Community Foundation of Carroll County but donor reserves the right to make recommendation to the Board of the Community Foundation of Carroll County.

- Catonsville High School will provide the Community Foundation of Carroll County with the recipient's name and a copy of their college acceptance letter.
- All income generated from the trust shall be used for the scholarship award or other approved charitable grant.
- The amount and number of the awards may vary based upon the earnings of the trust.
- The money shall be transmitted by the Community Foundation of Carroll County directly to the chosen college or university and applied directly to the student's tuition and books. The monies shall not be remitted to the scholarship winner directly. If a student does not enter school or having entered, drops out, the scholarship grant or part thereof refunded shall revert to the F. Lynn Mayer Memorial Fund.
- The Community Foundation of Carroll County in conjunction with the Scholarship Committee of Catonsville High School will determine the application process.
