



## ELIGIBILITY CRITERIA

### THE GINA MARIA BARNES WARRIOR FOUNDATION SCHOLARSHIP

**PURPOSE:** The purpose of the GINA MARIA BARNES WARRIORS FOUNDATION SCHOLARSHIP is to honor her memory and legacy by providing a scholarship for a Carroll County graduating female senior lacrosse player. The GINA MARIA BARNES WARRIORS FOUNDATION SCHOLARSHIP will be awarded to a graduating female lacrosse player who will be continuing the sport in college while pursuing an undergraduate degree at an accredited college, university or technical school who meets the criteria established for the fund.

#### FUND SELECTION CRITERIA:

- A. FUNDS will be awarded to an applicant who meets the following criteria:
1. The student will be a Female member of a Carroll County High School enrolled during the academic year for which the scholarship is awarded.
  2. The Female student will have been accepted at an accredited college, university or technical school.
  3. The Female student will have maintained a GPA of at least 2.5 for her high school career and have college worthy SAT scores.
  4. The Female student will have played lacrosse in High School and plans on continuing the sport during her college term .
- B. The administration of the FUND shall be as follows:
1. The recipient(s) shall be selected by the Donors or their designee, and approved by the Board of Directors of the Community Foundation of Carroll County. Donors reserve the right to make the award presentation.
  2. All income in the Fund shall be used for fund purposes.
  3. The money shall be transmitted by the Community Foundation of Carroll County directly to the desired college or university and applied directly to the student's tuition and books. The monies shall not be remitted to the FUND winner.



**GENERAL CONDITIONS:**

RESPONSIBILITIES OF FUND

The Community Foundation will transmit a check made payable to the institutions of higher learning chosen on or about August 1 of each year. The transfers will be in accordance with applicable regulations and laws governing such funds.

RESPONSIBILITIES OF BOARD

- A. The successful student recipients will be selected in accordance with the selection criteria identified in the Agreement.
- B. The Community Foundation of Carroll County shall administer the program in a prudent financial manner and the funds may be commingled with other funds of the Community Foundation of Carroll County.
